

[INTERNATIONAL CALL FOR SCORES] ENSEMBLE CONDUCTED BY BEAT FURRER

DESCRIPTION

Asociación Cultural AÏS, in collaboration with Festival Resis de Música Contemporánea de A Coruña and Arxis Ensemble, within the Vth edition of Festival Resis, announces the first International Call for scores.

Five pieces will be selected by the jury and rehearsed under the baton of Beat Furrer on May 22nd, 2022 in A Coruña. The pieces will also be played in an open performance that day.

PARTICIPANTS

The Call for Scores is open to any young composer under 35 years upon the deadline of the

registration, regardless of gender or nationality.

The submitted work must be a composition for chamber music group of a maximum duration of 10 minutes and in any combination of the following instruments: (minimum 2 instrumentalists)

- Flute (Flute in C/ Bass flute)
- Clarinet (Clarinet in Bb / Bass Clarinet)
- Percussion (1 instrumentalist) (5 octaves Marimba/ Suspended Cymbal/ stone / 2 Tom toms / Metal block / Tam tam / Timpani 32" / Glass (2 bottles) / Concert Bass Drum)
- Piano
- Violin
- Cello

If the score requires any other instruments/objects not mentioned in the list above (small percussion instruments, accessories, etc.), the composer must provide them themselves to the the ensemble before the first rehearsal. Otherwise, the organization might decide not to perform the piece.

Electronics or amplification are not allowed.

REGISTRATION

The participants must send and email to resis.convocatorias@gmail.com (Concept: NAME + LAST NAME - International Open Call) before April 30th, 2022 (23:59h) with the following documents:

- 1- Curriculum vitae in Spanish.
- 2- Copy of the Identity document or Passport.
- 3- Score of the work, composed in the last two years.
- 4- Proof of payment
- 5- (Optional) Sound recording of the submitted score. In the email you must include the link to the recording (website, youtube, soundcloud or similar).

This documents will be sent as attached PDF files.

The name of the files must not contain dots, accents nor any other kind of punctuation.

You may distribute the content in several emails. Be aware that the maximum per email is 20 MB.

On every email you must indicate your name, last name, postal address and phone number.

This conditions are mandatory in order to guarantee the proper reception of the documents.

The **selected composers** must send within 7 days after communication of the jury's decision, the following documents:

- Two pictures in high resolution and fee of copyright
- Biography (max.. 1000 characters).
- Parts of the selected work.
